INTEREST IS PAYABLE ON TIME ACCOUNTS AT THE RATE OF ONE AND SIX-HUNDRED TWENTY-FIVE THOUSANDTHS PERCENT (1.625%) PER ANNUM ON ALL DEPOSITS EFFECTIVE JULY 1, 2022. COLLATERAL IS HELD BY THE COMMONWEALTH TO SECURE PAYMENT OF ALL STATE DEPOSITS.
